- 3) I hereby guarantee the payment by the Tenant to you of the rent and any other money payable under the agreement and also that the tenant will comply with the terms of the agreement but in relation to rent only this Guarantee is subject to the limit contained in Clause A below.
 - a) My liability under this Guarantee in respect of the rent payable under the Agreement shall be limited to the Tenant's contribution to the total rent for the Property. This shall be calculated by dividing the total amount of the rent for the Property equally between the Tenant and the other persons liable as persons to pay the Rent in order to determine the Tenant's share and then deducting from this share all amounts, if any, actually received by you from the Tenant on account of the Tenant's contribution to the Rent. Otherwise, my Guarantee is unlimited
 - b) The tenant has signed a **joint and several tenancy agreement** and is **jointly and severally liable** with all of the other tenants to comply with the terms of the agreement. As I will be guaranteeing the tenants obligations under the agreement, this includes guaranteeing the tenants liability for any other tenant. This means that I agree that I am fully responsible for the payment of all money (beside the rent) and for the whole of the losses which may result if any other tenant breaks any of the terms of the tenancy if the tenant fails to pay.
- 4) The guarantor's estate becomes liable to the conditions of this agreement if they die while this agreement is being enforced.
- 5) The guarantor acknowledges that they have read and understood a copy of the tenancy agreement/contract and that they are signing without duress and that they have sought legal advice to both this guarantor form and the tenancy agreement.
